WAIVER & RELEASE

The Carol Stream Park District is committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. The Carol Stream Park District continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for the above listed programs/activities must recognize that there is an inherent risk of injury when choosing to participate in recreational activities/programs. You are solely responsible for determining if you or your minor child/ward are physically fit and/or skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

WARNING OF RISK

Recreational activities are intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury when participating in any recreational activity. Understandably, not all hazards and dangers can be foreseen. Depending on the particular activity, participants must understand that certain risks, dangers and injuries due to inclement weather, slip and falls, poor skill level or conditioning, carelessness, horseplay, unsportsmanlike conduct, premises defects, inadequate or defective equipment, inadequate supervision, instruction or officiating, and all other circumstances inherent to indoor and outdoor recreational activities exist. In this regard, it must be recognized that it is impossible for the Carol Stream Park District to guarantee absolute safety.

WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK

Please read this form carefully and be aware that in signing up and participating in the programs listed above, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with these programs (including transportation services and vehicle operations, when provided). I recognize and acknowledge that there are certain risks of physical injury to participants in these programs, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in these programs against the Carol Stream Park District, including its officials, agents, volunteers and employees. I have read and fully understand the above important information, warning of risk, assumption of risk and waiver and release of all claims. If registering on-line or via fax, my on-line or facsimile signature shall substitute for and have the same legal effect as an original form signature. Participation will be denied if the signature of adult participant or parent/guardian and date are not on this waiver.

Registration Information

Signing up for a trip is simple! Complete both sides of this form for the entire season. Then return it to the Simkus Recreation Center at 849 W. Lies Road, or fax it to (630) 289-1972, or register online at csparks.org. Include the correct Resident or Non-Resident payments and don't forget to indicate your pick-up location and Meal Selection (when necessary) for each trip. An individually signed waiver must accompany all program registrations.

We cannot accept registrations over the phone. Please make sure we receive your registration form and payment by the indicated deadline otherwise your spot will not be guaranteed. Space is often limited, so complete your registration early!

Accessibility

The Park District strives to provide trips and activities for everyone. Most Forever Young programs are handicap accessible. Please indicate on your registration form if you have special needs so that we can accommodate accordingly. If you have any questions about how strenuous a trip may be, please use the Activity Key as a guide and contact us for further information.

Pick-up Locations

Trip Refunds

We understand that trip cancellations sometimes cannot be avoided. Cancellations will be accepted prior to the due date. After that, refunds will be given if you find a replacement or a participant on the waitlist takes your spot.

Cancellations and Waitlist
