Discussion Items

A. Community Needs Assessment Update

Jarrod Scheuneman, Community Service and Education Coordinator for the University of Illinois at Urbana-Campaign, presented a PowerPoint reviewing the Community Needs Assessment results. The responses reflect the community cares about the Park District and enjoy the activities available, especially our special events, fitness center, mini-golf, playgrounds and walking paths. People are satisfied with the Park District Board of Commissioners and staff. Strength is the partnerships that have been developed throughout the community with local government, library and businesses. Commissioners complimented Mr. Scheuneman on the presentation and look forward to receiving the full report next month.

B. Carolshire and Community Park Update

Executive Director Reuter acknowledged that developing underserved communities like Carolshire and the neighborhood surrounding Community Park are important goals for the Board and staff alike. We had an opportunity to apply for the NRPA Disney grant to meet the needs of the Carolshire residents. The grant, if awarded, will contribute up to \$50,000 toward the project and we will coordinate with the parking lot resurfacing project starting soon to make the new play space ADA accessible. Commissioner Gramann expressed concern about the site being so close

to Gary Avenue. Executive Director Reuter concurred, stating that there would be some kind of barrier like shrubbery or possibly even a fence. We are also hoping the Gary Avenue Bike Path will have an access point into the park. Commissioner Bird asked about OSLAD funds. Executive Director Reuter referred to the many requirements for that type of grant which makes meeting the criteria difficult to qualify.

Community Park is still owned by the Village of Carol Stream. The Park District only wants to maintain four parcels which would include walking paths, baseball and soccer fields, basketball and volleyball courts and a picnic shelter. Commissioner Sokolowski commented how beautiful the trees are in the wooded area. Commissioner Gramann recalls this park has been on the Board's wish list for quite some time. She is hopeful that we can annex those four parcels and make it into a nice park. Commissioner Sokolowski hopes the Forest Preserve moves to protect the wetlands. Executive Director Reuter remarked that the park was developed with Land and Water Conservation funds many years ago.

C. Weekly Happenings

- Commissioner Gramann asked if we ever looked into a vendor to provide towel service or perhaps investing in towels with a stripe to identify them as Fountain View Recreation Center property. These steps could save money in laundry and loss by people accidently taking the towels home.
- Commissioner Jeffery is working on the list of Memorial Park Events. We will be sending out e-blasts and Facebook posts to let the community know about the Touch a Truck and Drive 4UR Community Event scheduled for August 5 at McCaslin Park. Joe Cotton Ford is participating in the test drive fundraiser. We are looking for volunteers to help set up and clean up and also chaperone the test drives. The Stars and Stripes Shuffle will take place October 1 at Armstrong Park. Commissioner Bird commented that the Summer Concerts at the Town Center generate interest in the Memorial Park fundraisers.
- Commissioner Powers commented he still has some questions about the audit. Executive Director reminded him the auditors will respond directly to him about this.
- Director Haring informed the Board about a conversation he had last week
 with the Liquor Commission. They requested more detailed information
 about our liquor insurance coverage. PDRMA will present another document
 showing that our coverage provides sufficient coverage to address their
 concerns. Director Haring will submit it to the county with a map detailing all
 areas of coverage.
