Fees vary by month based on the number of scheduled attendance days. An Automatic Payment Request form is required with registration.  A nonrefundable enrollment fee and your first month's payment are due at registration. All subsequent payments are drafted from a bank account or credit card approximately one month in advance from August-May. First scheduled payment is August 1. Full payment schedule is listed on receipt. The early bird enrollment fee is \$55 if registering by June 30 and \$70 if registering on or after July 1.  Registrations and schedule changes within seven days are charged a \$5 fee per child per day and require supervisor approval. Credits and refunds are not provided for any payments that have already been processed or for absences of any sort. If a participant withdraws and reenrolls in the same school year, the enrollment fee must be repaid. Enrollment fees are also non-refundable.
