3.	Listening Post	Names: Carol Floren, Reverend Sara Snowden, Chip Snowden, Jan Smith, Karen Maurer, Clem Malinowski, Dana Hybl, Pam Falco, Heritage Presbyterian Church members. Carol Floren, President of the Carol Stream Parks Foundation Board presented a \$9,000 donation check to the Carol Stream Park District for its Scholarship Program. This donation was in part made possible by donations from Heritage Presbyterian Church's Dare to Dream Taskforce which contributed 100% of their fundraising proceeds to the Foundation; the Relay for Life Fundraising Bags Tournament hosted by Village Trustee Matt McCarthy; the Foundation's signature Duck Race event; and donations from community businesses.

Review of Board Attendance Guidelines</p> <ul style="list-style-type: none"> Commissioner Jeffery reviewed the statutory attendance requirements for board members, as well steps for advance notice for an expected absence. Not having a quorum limits the Board from taking any action, and wastes time for others (referring to February 26 Board meeting). As soon as you know you can't attend, please contact Commissioner Jeffery and Executive Director Rini. Please respect staff and commissioners' time. Commissioner Del Preto has resigned from the Board; he has spoken to each Commissioner personally. His resignation is the result of the demands on his time due to his new job. The Board will be tasked with appointing someone to fill his position through the end of his term on 4/30/2025. President Jeffery asked for the other board members to pass along any suggestions for candidates, and the process. <p>B. DCEO Grant Update</p> <ul style="list-style-type: none"> Executive Director Rini shared staff's recommendation for use of the \$50,000 DCEO grant. She gave a recap of the current Capital Improvement Plan priority listing. Pickleball is the next unfunded project on the list. Staff recommends we use the grant to complete this project, which will address the most frequently requested amenity identified in the 2023 Community Needs Assessment. Commissioners all agreed. Rini noted that staff will move forward with the project and grant. <p>C. Weekly Happenings</p> <ul style="list-style-type: none"> Executive Director Rini thanked the group for helping with the Legislative Breakfast on Friday, March 1. The event, which hosted over 130 legislators, and parks and recreation elected officials and professionals, was well received. We hope to host the event again in 2025. Commissioner Gramann went to a new indoor pickleball facility called "Pickled." She was impressed by the amount of people there. She talked to the owner, learned about classes available, and saw a party there. Commissioner Gramann also attended Relay for Life bags tournament and fundraiser, adding it was a great. Commissioner Bird recommended we do a Park Night next year. Commissioner Jeffery thanked CSPD for hosting a table at the WDSRA Bash. It is for a great cause. Commissioner Sokolowski asked how Jan Smith Park is doing. Director Hamilton said he met with her last week and all is good. She comes by about once per month to make sure the park is taken care of. Commissioner Sokolowski commented on the rental revenues being high. He asked if staff sees a slowdown in other program areas. Director Bachewicz said Before & After Care and Adult Trips are not

Executive Director Rini said that since the pandemic, more people work from home and can avoid needing before and after care during the school year, but when summer is coming they are signing up the kids for camp.</p> <ul style="list-style-type: none"> • Commissioner Sokolowski went to the Citizen of the Year banquet. He asked if we do anything for nominees. Director Bachewicz replied that nominees are recognized in our E-News. He asked if we can show something all year to showcase the community volunteers. Staff replied that we could do a monthly spotlight for this. • Commissioner Witteck was sick last week and didn't make it to the Legislative Breakfast, but was happy that other West Chicago Park District staff said it was great. Commissioner Jeffery added that the new CSPD backdrop was great and door greetings helped the event. • Commissioner Jeffery thanked those who attended Mayor Saverino's wife's services.

Approval: Intergovernmental Agreement - Carol Stream Park District and the Village of Carol Stream for Klein Creek Section 21 - Memorial Park Through Grant funding, the Village of Carol Stream constructed a pathway from Kuhn Road to Memorial Park, including the installation of a retaining wall, and bioengineering measures to stabilize the Klein Creek stream banks. The agreement spells out how the Village and the Park District will share the costs associated with long-term maintenance of the native vegetation that falls within the Park District property. 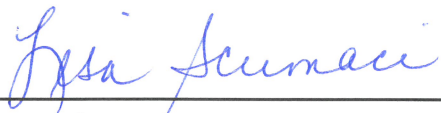

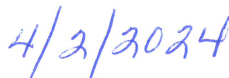

As is discussed in the Board Policy Manual, Section 2.11 (*excerpt included as Agenda Item 7C*), the Board has the authority to make an appointment to fill the open position created by former Commissioner Del Preto's resignation. The replacement shall be appointed by a majority vote of the remaining board members. Issue

Should the Board make a motion to approve wording corrections in the Board of Commissioners Policy Manual, Section 2.11.

Background/Reasoning

During review of the Board of Commissioner Policy Manual, typos and duplicate wording were noticed in section 2.11. The policy does not mirror the law (70 ILCS 1205/2/-25)

Current Wording

2.11 Vacancies in Office

A. Declaring a Vacancy

A vacancy on the Board may be declared whenever any member (1) dies, (2) resigns, (3) mental or physical disability, (4) change of required residency, (5) is convicted of any disqualifying crime, (6) refuses or neglects to take his oath of office, (7) neglects to perform the duties of this office or to attend meetings of the Board for the length of time as the Board fixes by Ordinance No. 375 {see exhibit D}, or (8) for any other reason specified by law. (70 ILCS 1205/2-25).

B. Method of Filling Vacancies

Vacancies shall be filled by appointment by a majority of the remaining members of the Board. The appointee (after the required vote) will be sworn in with the reference “to complete the term vacated by Commissioner _____.”

Any person so appointed shall hold his office until the next regular election at which time a qualified candidate shall be elected to fill the vacancy of the unexpired term. However, if the vacancy occurs with less than 28 months remaining in the term or with less than 88 days before the next regularly scheduled election, then the person appointed to fill the vacancy shall hold his office until the expiration of the term for which he has been appointed, and no election to fill the vacancy shall be held. (70 ILCS 1205/2-25).

If the vacancy occurs with less than 28 months remaining in the term, the person appointed to fill the vacancy shall hold the office until the expiration of the term for which he or she has been appointed, and an election is not required. If the vacancy occurs with more than 28 months left in the term, but less than 123 days before the next regularly scheduled election for Board members, the person appointed to fill the vacancy shall hold the office until the second regularly scheduled election for the office following the appointment, at which a member must be elected to fill the vacancy for the unexpired term (70 ILCS 1205/2-325).

Suggested Changes

2.11 Vacancies in Office

A. Declaring a Vacancy

Whenever any member of the governing board of any park district (i) dies, (ii) resigns, (iii) becomes under legal disability, (iv) ceases to be a legal voter in the district, (v) is convicted in any court located in the United States of any infamous crime, bribery, perjury, or other felony, (vi) refuses or neglects to take his or her oath of office, (vii) neglects to perform the duties of his or her office or attend meetings of the Board for the length of time as the Board fixes by Ordinance No. 375 [see exhibit D], or (viii) for any other reason specified by law (70 ILCS 1205/2-25).

B. Method of Filling Vacancies

Vacancies shall be filled by appointment by a majority of the remaining members of the Board. The appointee (after the required vote) will be sworn in with the reference “to complete the term vacated by Commissioner _____.” Any person so appointed for this office, at which a member shall be elected to fill the vacancy for the unexpired term, subject to the following conditions:

- (1) However, if the vacancy occurs with less than 28 months remaining in the term ~~or with less than 88 days before the next regularly scheduled election~~, then the person appointed to fill the vacancy shall hold his ~~or her~~ office until the expiration of the term for which he ~~or she~~ has been appointed, and no election to fill the vacancy shall be held. (70 ILCS 1205/2-25).
- (2) If the vacancy occurs with more than 28 months left in the term, but less than 123 days before the next regularly scheduled election for ~~Board members~~ this office, the person appointed to fill the vacancy shall hold the ~~his or her~~ office until the second regularly scheduled election for the office following the appointment, at which a member ~~must~~ shall be elected to fill the vacancy for the unexpired term (70 ILCS 1205/2-~~325~~ 2-25).

Cost

Having policies that mirror wording in IL Statute allows the Park District to operate in accordance with the law.

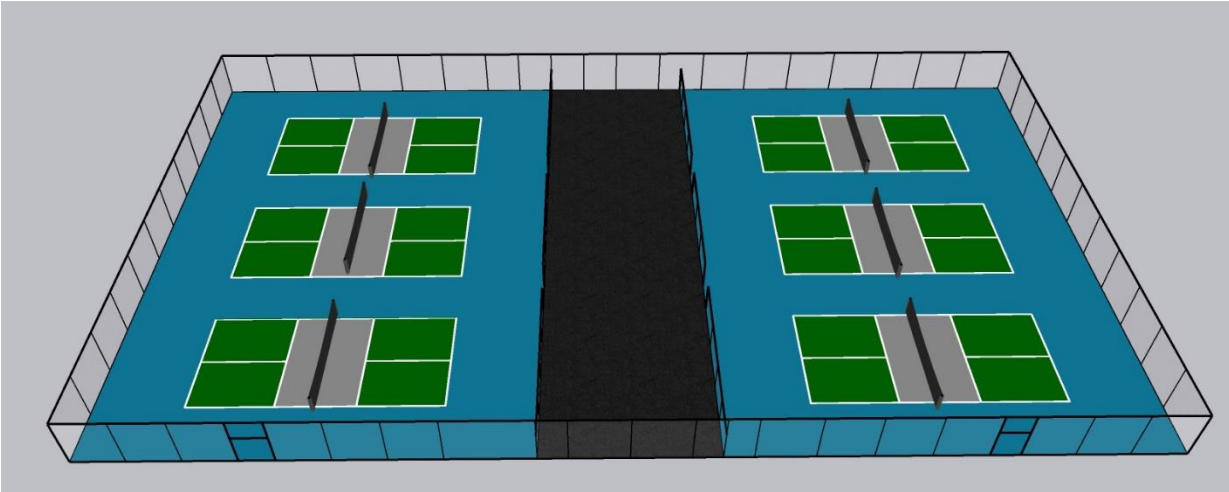
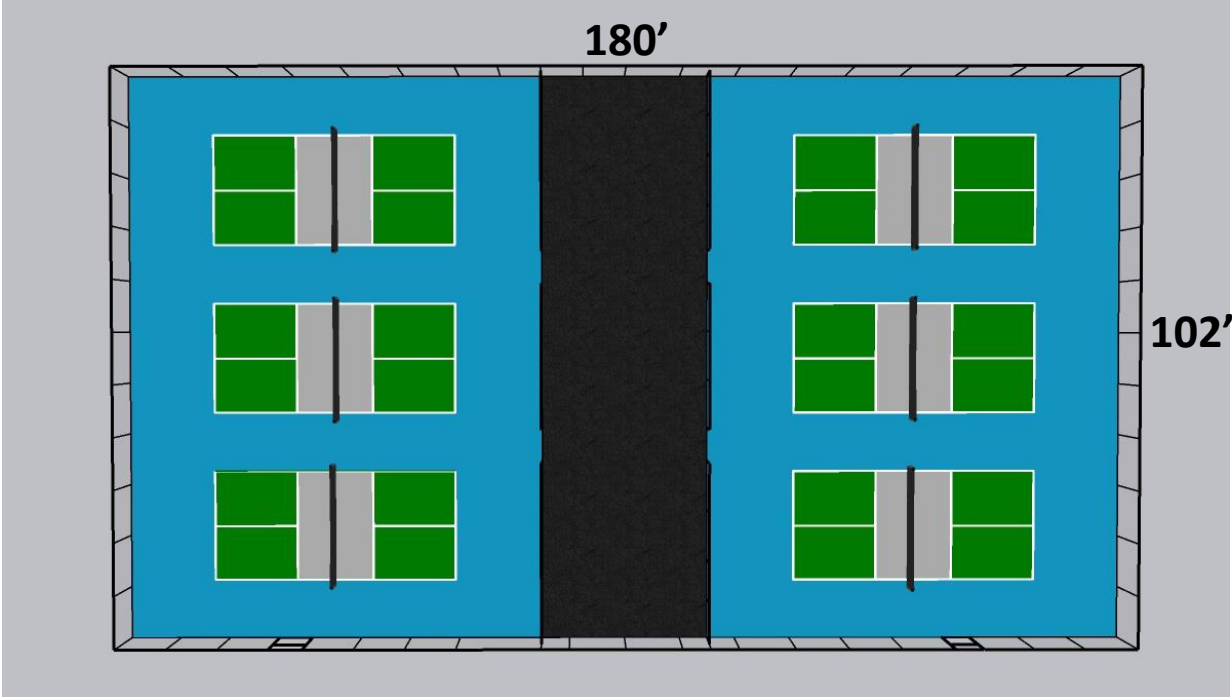
